Elementary Principal Teeling discussed the all-day professional development scheduled for October 28th where we will host Springville and North Cedar, the recent Community Development breakfast at Cornell, Lisbon, Inc. and how they partner with local businesses, Homecoming week, and thank you to Mt. Vernon Bank for last week's tailgate before our football game.

Superintendent Hocking noted that our FY19 audit was very good and the unspent balance is up, solvency is down. He attended a Washington, DC conference last week and was able to speak with several of our representatives about the special ed deficits, E-Rate, Title IV funding, and mental health issues.
